Treasurer's Report – Fiscal Year End 2022-2023

This Treasurer's Report references the fiscal period of July 1, 2022 to June 30, 2023.

The 2022-2023 Budget was approved by the OPWA Board in June 2022 providing in essence a balanced budget with a projected surplus of \$4,630. During the 2022/2023 fiscal year, many of OPWA's events returned to being held in person in addition to a few virtual webinars and technical sessions.

As a result of events being extremely well attended, the Annual Sponsorship Program returning to previous levels, increased memberships and close attention to event and association expenditures, OPWA finished its fiscal year end 2022-2023 with revenues over expenses of \$41,614.60.

As of June 30, 2023, OPWA is in a strong financial position as stated by its Balance Sheet, with cash assets in the bank account, plus investment assets of over \$173,712.56

2023-2024 Budget

The OPWA Board approved a balanced budget of \$369,500.00 with the expectation of revenues from in-person events and the continued support of our annual sponsors, resulting in an expected revenue over expenses of \$50.00. The balance of the 2023-2024 fiscal year will include revenues from the Summit Expedition, Awards Luncheon, Technology Showcase, International Women's Day, DEI Events, Right of Way Management Conference, and Golf Day.

A sincere thank you for the generosity of our annual sponsors. The fiscal year 2023-2024 had a commitment of \$39,000.

I would like to express my thanks to the many people that have assisted me in the Treasurer position this past year, including OPWA's President Doug Keenie, Executive Director Brian Barber and the OPWA Executive Committee. I would also like to thank Lingling Liu at OGRA for their financial services and assistance over the past year. Lastly, I'd like to thank Lorri Roth at APWA National for her ongoing support and assistance.

- Evaluated submissions for Project of the Year Awards for projects completed in 2022. Facilitated the Annual Awards Luncheon during National Public Works Week when awards were presented to the winning submissions. Over 172 attendees were present at the luncheon for the presentation of 13 Project of the Year Awards and 3 individual awards.
- The 2022 Merit Service Award was presented to Don Kudo of the County of Wellington, Terry Hardy Exemplary Service Award was presented to Peter Noehammer of the Town of New Market and the Wally Wells Yong Leader Award was presented to Simon Chue of the Region of Peel.
- The awards program was revamped to accomplish several goals including: recognize categories that have become more prominent over the last several years, recognize the contributions of Municipal Works staff not just projects, to encourage large and small municipalities to submit projects, to streamline the application process to encourage members to submit people and projects, to reduce the cost and time of submitting projects. The new awards program was reviewed and approved at the November 28, 2023, OPWA Board Meeting.

- Recognize excellence in Public Works projects and personnel achievements among the OPWA membership.

The ROW Committee's mandate is to develop relationships, knowledge and best practices that will educate users and stakeholders on the efficient use and management of the public right-of-way. To facilitate this, the ROW Committee is comprised of the 5 following subcommittees – activities and accomplishments of each subcommittee in 2023 are listed below. Council of Chapters Update January 2024

The Council of Chapters is comprised of one delegate from each of the 63 APWA Chapters. Members of the council serve APWA as advisors to the Board of Directors, Executive Director, Technical Committees, Tasks Forces, and staff in support of the mission of APWA in accordance with the association's bylaws and parliamentary procedures. Delegates also function as a conduit in sharing the opinions and ideas of their chapters and serving as points of contact at the local (chapter and branch), regional, and national levels for the dissemination of information to and from members.

The mission of the Council of Chapters is to increase the effectiveness of the association by:

- Advising the Board of Directors, the Executive Director, staff, and Chapters on goals, strategies, and issues that are referred to the Council.
- Supporting the APWA Strategic Plan and influencing changes for the betterment of the association.
- Supporting Chapter-to-Chapter mentoring and development of best practices to strengthen the services delivered in each chapter.
- Communicating member issues among the local, regional, and national levels
- Identifying dedicated members for active participation within the association.

The first meeting for 2023 for the Council was Chapters was held on August 26, 2023, in San Diego during PWX. Each Chapter Delegate submitted a brief report outlining membership goals, chapter events held to date during 2023 and planned activities for the balance of the year.

The agenda for the August meeting included a presentation by the President-Elect of APWA, now President, Gary Losier P. Eng. (Canadian) and CEO Scott Grayson. APWA is in good financial shape and has seen an increase in membership to over 32,000

members. The APWA Board approved a new reserve policy which requires reserves that are 85% of the operating budget, developed a new initiative fund that can be accessed by Chapters and have established a meeting cancellation fund that is to grow to \$7.5 million in 8 years.

Other topics of interest for 2023 include:

- The new enterprise-wide software, Fonteva, went into operation.
- New website for APWA and the Chapters.
- Release of the 2023 2026 Strategic Goals and Activities.
- Continued advocacy in Washington D.C. and Ottawa.
- Held meetings with Big Cities/Counties in the U.S. and Canada.

Breakout sessions were held on Membership 101, Engaging Young Professionals Post Covid, and Developing mutually beneficial Partnerships with Complimentary Associations. Information generated from these sessions will be used by APWA staff to develop material for use by the Chapters.

APWA has initiated a new format for the next winter meeting of the Council of Chapters whereby members of the Council would meet with just members from their respective Regions. Ontario is in Region 5 which consists of Ontario, Michigan, Chicago Metro, Illinois, Indiana, Ohio, and Wisconsin. The meeting will be held in Kansas City, MI on February 22, 2024. Topics to be reviewed include Strategic Plan Update, review of best practices and several information sharing sessions.
